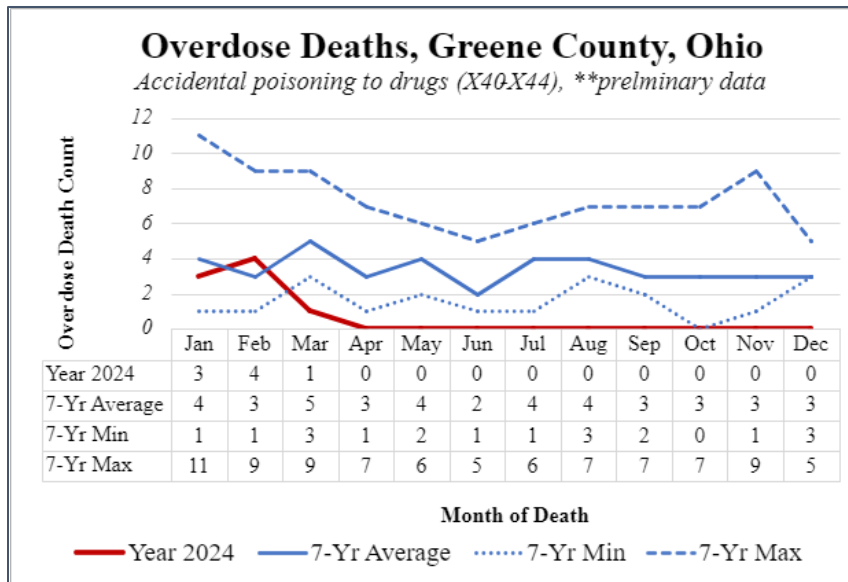
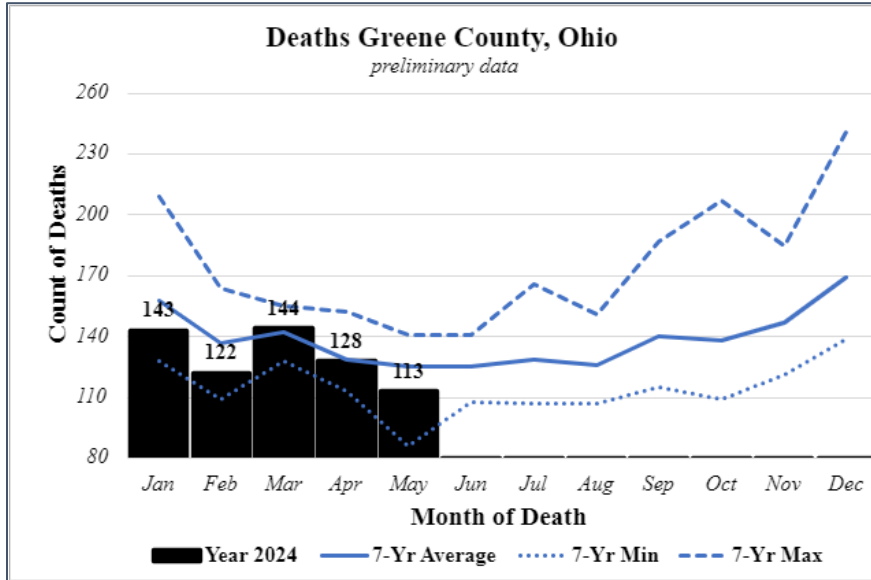
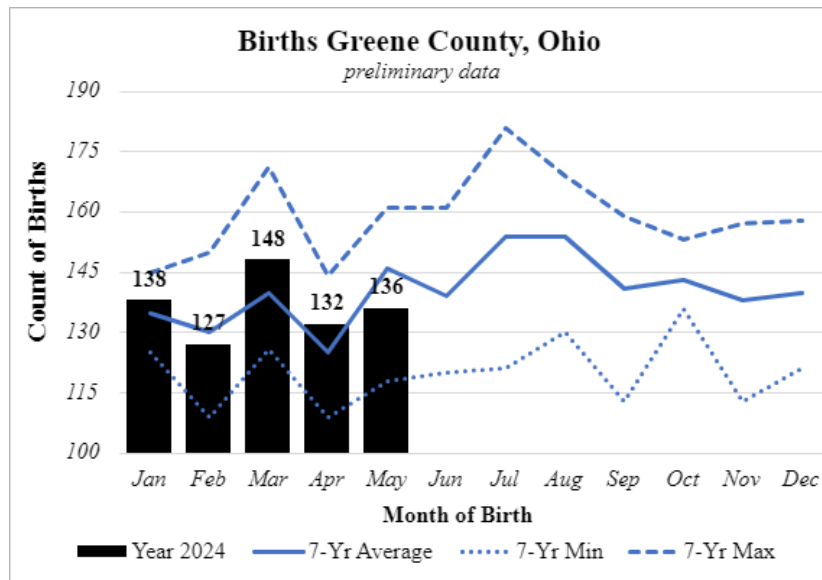

b. *Emergency Preparedness*

i. **Medical Reserve Corps**

- (1) June 29, 2024, the volunteers will staff a medical first aid station in Yellow Springs during the 2024 Pride festival.
- (2) The unit was just awarded \$20,000 as a subgrantee of the Medical Reserve Corps (MRC) State, Territory and Tribal Nations, Representative Organizations for Next Generation (MRC-STTRONG) award under the American Rescue Plan strengthen the MRC network – focusing on emergency preparedness, response, and health equity needs. The award will cover some of the personnel, including travel, and equipment.

3. **Environmental Health**

- a. *Food Establishment/Food Service*
 - i. R. Schairbaum and M. Straight taught a ServSafe course on June 5, 2024 and June 12, 2024 for nine individuals; one student retested. To date, Greene County Public Health has conducted two food training courses for a total of 17 students; one proctored exam session; three retests.
 - ii. Staff members have completed 1,137 inspections on risk level I, II, III, and IV food service operations / retail food establishments, 47 inspections for in-county food mobiles, 69 consultations for out-of-county food mobiles, and 57 food temporaries.
 - iii. Staff members performed food temporary and mobile inspections for the following festivals: Stronger Together Concert, Creek Classic, Yellow Springs Street Fair, Jamestown Street Fair, and single temporary license events.
- b. *Mosquito*
 - i. J. Marks and D. Shontz are studying in preparation to get an aerial license to apply pesticides for getting the mosquito drone.
- c. *Sewage*
 - i. Special Services received notification from Ohio Department of Health (ODH) that they will receive their first sewage program survey in late August, 2024.
- d. *Solid Waste*
 - i. Second quarter solid waste inspections have been completed.

4. **Health Education**

- a. *Harm Reduction*
 - i. We are expanding our partnership with Violence Free Futures by offering human immunodeficiency virus (HIV) sexually transmitted infection (STI) education and testing services for HIV, hepatitis C virus (HCV), and syphilis.
 - ii. Integrated Harm Reduction Grant ODH site visit, 06/28/24.
 - iii. Tabling at multiple Pride events throughout Greene County: Beavercreek - 06/09/24, Fairborn - 06/21/24, Yellow Springs - 06/29/24. (K. Day, C. Holley, A. Romer)
 - iv. Share 1:1 Clothing Closet harm reduction tabling on 06/11/24. (C. Holley)
 - v. Child Safety event collaboration with Fairborn FISH and Fairborn Fire Department was a success on 06/04/24, checking all car seats for proper installation, educating on safe sleep practices, and distributing 15 pack-and-plays, and education on overdose prevention with Narcan distribution.  - vi. Collaborated outreach with Goodwill Easter Seals at Yellow Springs Street Fair on 06/08/24 distributing Narcan, safe sex kits, and medication disposal bags.
 - vii. Harm reduction collaboration with HIV to provide testing for HIV, HCV, and syphilis at Beavercreek Walgreens for National HIV Testing Day.

4. **Maternal Child Health**

- a. *Baby Me and Tobacco Free*
 - i. T. Sparks assisted in wrapping up the Baby & Me Tobacco Free Grant year by providing final visits and preparing families to transfer to the on-line program.

- b. *Help Me Grow Home Visiting*
 - i. Department of Children & Youth (DCY) continue to support our families through their incentive retention program, and we can purchase Kroger gift cards for our participating families.
- c. *Healthy Families America (HFA)*
 - i. C. Washburn was approved for her provisional credential.

5. **Early Intervention (EI)**

- a. This month has been busy beginning to learn new forms, develop new procedures to meet new EI rule requirements. One of the biggest changes to the rules is that once a child is made eligible, the child will remain eligible until age three. Staff will no longer need to re-determine eligibility annually. The state fiscal year (SFY)25 agreement has been signed and is in place for the upcoming year. All the SFY24 funds have been spent including marketing and outreach.
