GREENE COUNTY PUBLIC HEALTH MONTHLY ACTIVITY REPORT July, 2024

1. Foundational Capabilities

- a. Epidemiology
 - i. Completed risk assessment of Greene County residents who were potentially exposed to bats at a camp in Richland County, Ohio between June 23, 2024 and July 4, 2024. If the risk was elevated those persons were referred to Dayton Children's Emergency Department for post-exposure prophylaxis for rabies.
 - ii. *Candida auris* outbreak at a nursing home can now be closed as no new cases were observed after 28 days.
 - iii. An outbreak of enteric illness associated with a bakery can now be closed.
 - iv. An outbreak of scabies is under control at a local shelter. Scabies (*Sarcoptes scabiei var. hominis*) is an infestation of the skin by a human itch mite. Scabies cause intense itching and a pimple-like skin rash. Human scabies is most commonly spread by direct, prolonged skin-to-skin contact with a person who has scabies. The staff at the shelter worked successfully with Greene County Public Health to control the outbreak. All known cases have been treated.

b. Emergency Preparedness

i. The Medical Reserve Corps (MRC) units of the West Central Ohio region public health departments, including Greene County, are hosting severe weather training for MRC volunteers and staff on Saturday, July 13th from 1:00 pm to 4:00 pm at Romer's Catering, 201 Robert M. Davis Parkway, Piqua, Ohio. The training will include how to prepare for severe weather and how to assist those with disabilities during a disaster/emergency. The presenters include Marc Burdiss from Preparedness Solutions, Inc. and Maria Matzik from the Access Center for Independent Living. The training is provided through a grant awarded by the Ohio Department of Health, Bureau of Health Preparedness MRC State, Territory and Tribal Nations, Representative Organizations for Next Generation (MRC-





STTRONG) Program. The first 150 registrants will receive a Midland Weather Radio.

3. Environmental Health

- a. Food Establishment/Food Service
 - General and Special Services team members performed inspections at the Yellow Springs Pride Event, Fairborn Block Party, Yellow Springs 4th of July, Beavercreek 4th of July, Sonnycalb Fireworks, Red, White & Blue Xenia Block Party, and other various single events where temporary licenses were issued.

b. *Mosquito*

i. The mosquito control program continues with new trapping locations being identified. To date, NO mosquito pools from Greene County have tested positive for pathogens.

c. Sewage

i. Special Services have the first two sewage designs for the water pollution control loan fund (WPCLF) which provides financial and technical assistance for improvements to surface and ground water quality; bids for installation contractors will soon follow.

d. Solid Waste

i. Greene County has registered/licensed its first Class 2 composting operation—a vessel composter in Miami Twp. A Class II compost facility is authorized to accept specific feedstocks, bulking agents, and additives for composting. These facilities are required to register, obtain an operating license, and establish financial assurance. The accepted materials typically include yard waste, agricultural plant materials, dead animals, raw rendering material, animal waste, food scraps, and authorized alternative materials.

4. Health Education

- a. Healthy Eating Active Living (HEAL)
 - i. Per the results of the HEAL walk audits in Fairborn, a bench and trash receptacle were placed in Fairborn near the FISH pantry on Funderburg Road.
 - ii. To unveil the community enhancements, a Fairborn Clean-Up Day will be held on Tuesday, August 13, 2024 from 10:00 am-1:00 pm. This will give an opportunity for Fairborn residents and partners to come together to create a cleaner environment. Results of the walk audit showed substantial amounts of litter and debris in walkways of residents.
 - iii. Greene County Public Health was awarded the Creating Healthy Communities (CHC) Program which will expand HEAL efforts. The CHC program will begin in October.

- i. City of Fairborn annual July 3, 2024 Block Party (L. Gonyer, C. Holley). Safe Communities items were distributed along with our new promotional items (water bottles, safety kits, hand sanitizer).
- ii. There were five fatalities reported to the media for the third quarter of the Safe Communities grant (May-June). Greene County currently has seven fatalities for the year 2024. There were five fatalities in 2023.
