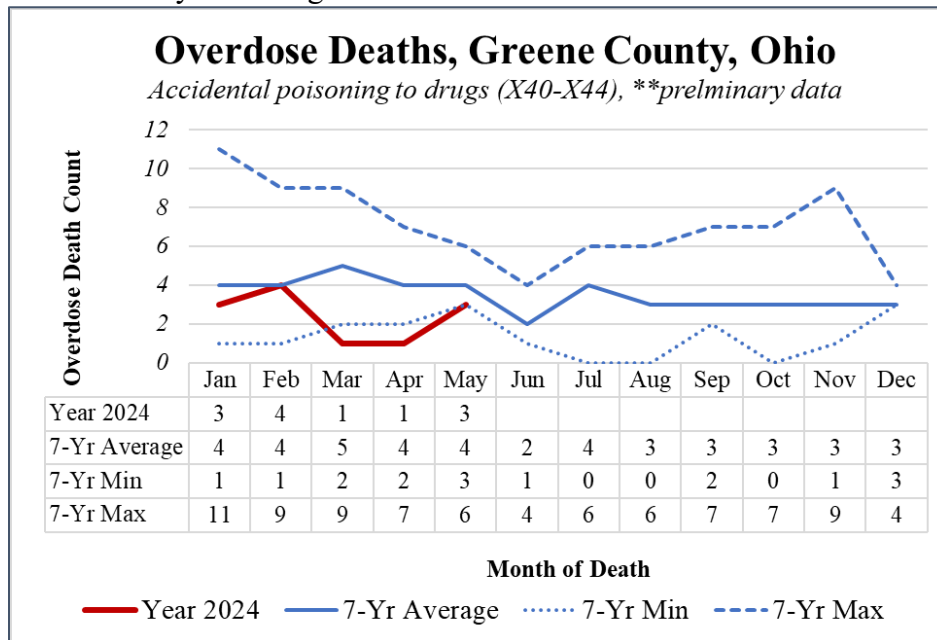

b. *Emergency Preparedness*

i. Greene County GuardCare 2024

- (1) Greene County Public Health (GCPH) partnered with the Ohio Department of Health (ODH), the Ohio Army National Guard, Air Force Active Duty, Air Force Reserves, and the United States Public Health Service, to host GuardCare, a two day no-cost healthcare event and health fair on August 10, 2024, and August 11, 2024. Additionally, the Greene County Career Center, Remote Area Medical, Delta Dental, Kettering Health, and fourteen other partners contributed to the success of this event through a continued cooperation in a civil, state, and military partnership by providing a venue for the event, eyeglasses, and essential medical supplies.
- (2) During the event an extensive range of services including medical, dental, optometry, eye glass fabrication, mental health, physical therapy, diet and nutrition, immunizations, audiology, laboratory, sports physicals, mammograms, lead testing, sexual health, hemoglobin, child development, pregnancy testing, breastfeeding, and other health fair services.
- (3) Services were provided to 1,028 community members, delivering approximately \$604,133.10 in fair market value medical care across the patients, Remote Area Medical (RAM) produced 311 pairs of eyeglasses, Ohio Department of Health delivered 391 vaccines, and Kettering Health provided 536 laboratory specimens and testing services, all at no cost to the community. Follow up care for all services necessary will continue with ODH, GCPH, and other entities, ensuring the continuing health care impact in Ohio.

3. **Environmental Health**

a. *Food Establishment/Food Service*

- i. During August, Rick Schairbaum taught three Person in Charge (PIC) classes for Wilberforce University, Cedarville University and City of Xenia school system. A total of 69 participants attended these three classes. The last ServSafe class for 2024 will be taught on October 14, 2024, and October 21, 2024.
- i. During the past month, Environmental Health employees performed inspections for the Greene County Fair, Fairborn Bluegrass & Brew, Fairborn Sweet Corn Festival, Bellbrook Lion's Summerfest, Clifton Music Festival and other minor temporary food operations. To date, a total of 106 temporary food licenses have been issued for the 2024 food licensure year.

b. *Mosquito*

- i. The mosquito control program continues with new trapping locations being identified.
- ii. The summer's second application of mosquito adulticide was applied in Beavercreek, Bellbrook, Fairborn, and Xenia.

c. *Sewage*

- i. Special Services has accepted two bids for the water pollution control loan fund (WPCLF) projects and has three more in the process.

- d. *Solid Waste*
 - i. Special Services continues to monitor the progress of local and state agencies regarding illegal dumping and an unlicensed transfer facility.
- e. *Swimming Pool*
 - i. The General Services team has been working on completing the final round of outdoor swimming pool & spa inspections before the pools close for the season.

4. **Health Education**

1) *Healthy Eating Active Living (HEAL)*

- a) Held a Fairborn Clean-Up Day on August 13, 2024, to celebrate the unveiling of a new public bench and trash can near the Fairborn FISH Food Pantry. Fairborn partners and residents participated in picking up litter on Funderburg Road, the FISH pantry, and Wright Park. Eight trash bags of litter and debris and four baggies full of cigarettes were picked up.

2) *Safe Communities*

- a) Loressa Gonyer participated in Greene County's OVI Checkpoint on August 16, 2024, alongside the Ohio State Highway Patrol (OSHP).
- b) Loressa Gonyer and Safe Communities Coalition member, AAA, recorded Greene County Public Health (GCPH)'s October podcast on Halloween safety, teen driver safety, and seatbelt use with Laurie Fox.
- c) Attended Wright State University's international student resource fair and distributed safe driving materials/items, Narcan, safer sex kits, tobacco resources, COVID test kits, and Deterra drug disposal bags.
- d) The Drive Sober or Get Pulled Over kickoff event was held at the Trans Am Nationals in Fairborn. The Safe Communities Coalition held a press conference to discuss the dangers of impaired driving. Lieutenant Hilderbrandt, OSHP, spoke at the press conference and Motorcycle Ohio presented two Saved by the Helmet awards.

3) *Tobacco*

- a) Collected three stories from current and former tobacco/nicotine users at GuardCare that will be used to support future policy work.
